# REALITY STRIKES ACADEMY WHISTLEBLOWING POLICY 2025-26

#### 1. Purpose

Reality Strikes Academy is committed to the highest standards of openness, integrity, and accountability. Staff, governors, volunteers, and contractors are encouraged to raise concerns about malpractice, wrongdoing, or risks to pupils, staff, or the Academy community without fear of reprisal.

## This policy aims to:

- Provide clear procedures for reporting concerns.
- Protect whistleblowers from victimisation.
- Ensure concerns are taken seriously and dealt with appropriately.

# 2. Scope

This policy applies to:

- All staff (permanent, temporary, supply, and agency staff).
- Governors, volunteers, and contractors working on behalf of the Academy.

Concerns may include, but are not limited to:

- Safeguarding or child protection failures.
- Criminal activity.
- Breaches of legal or professional obligations.
- Misuse of Academy funds or property.
- Health and safety risks.
- Discrimination or unethical conduct.
- Deliberate concealment of malpractice.

## 3. Principles

- All concerns will be treated seriously and investigated promptly.
- Confidentiality will be maintained wherever possible.
- No whistleblower will suffer harassment or retaliation.
- Malicious allegations may result in disciplinary action.

#### 4. Reporting a Concern

Concerns should be raised at the earliest opportunity. Staff may raise issues verbally or in writing.

# Step 1: Internal reporting

#### Step 2: Governing body / Proprietor

# **5. Investigation Process**

- The concern will be acknowledged within 5 working days.
- An initial assessment will determine next steps (formal investigation, referral, or resolution).
- Outcomes may include disciplinary action, referral to external agencies, or no further action (with rationale explained to the whistleblower).

#### 6. Protection for Whistleblowers

Reality Strikes Academy is committed to ensuring that whistleblowers are not subject to:

- Dismissal, demotion, or loss of opportunity.
- Bullying, harassment, or victimisation.

Whistleblowers are protected under the Public Interest Disclosure Act 1998 if the disclosure is made in good faith.

# 7. False or Malicious Allegations

Concerns made in good faith will always be protected. However, deliberate false or malicious allegations may result in disciplinary action.

# 9. Monitoring & Review
